Challenge Rules

1. The challenge consists of eating ten (10) hot dogs, including buns, within twenty (20) minutes.
2. The timer begins when instructed by a Starvin Marvin's employee.
3. No food may be shared, discarded, or intentionally hidden.
4. Participants may consume water during the challenge. No outside food or beverages are permitted.
5. Once the challenge begins, it may not be paused.
6. If completed successfully, the participant receives a Starvin Marvin's Champion T-Shirt, a photo on the Wall of Weeners, and qualification for the Championship Event (subject to future event rules).
7. If the challenge is not completed, the participant agrees to pay for any hot dogs not finished before leaving the restaurant.
8. Management may stop the challenge at any time if continuing appears unsafe.
9. Management's decision regarding completion is final.

Health Acknowledgment

I certify that I am participating voluntarily, am at least 18 years old (or have parent/guardian consent if permitted), am not aware of any medical condition that would make participation unsafe, and understand that rapid food consumption may result in choking, nausea, vomiting, aspiration, stomach discomfort, illness, or other serious injury.

Assumption of Risk

I voluntarily assume all risks associated with participating in this eating challenge, whether known or unknown.



Release of Liability

To the fullest extent permitted by Arizona law, I release and hold harmless Starvin Marvin's Flatburgers, its owners, officers, employees, managers, affiliates, successors, and agents from claims arising from my voluntary participation, except where liability cannot legally be waived, including claims involving gross negligence, reckless conduct, or willful misconduct.
